AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF SLAYTON, MURRAY COUNTY, MINNESOTA, TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND ABUTTING THE CITY LIMITS.

WHEREAS, a certain petition dated November 5, 1975, requesting annexation of the territory hereinafter described was received by the City Clerk on the 6th day of November, 1975, and was duly presented to the City Council on the 17th day of November, 1975; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 5.90 acres of platted land, no part of which is included within the limits of an incorporated city, or borough; and

WHEREAS, the petition was signed by all owners: and

WHEREAS, no objections to the annexation have been received from the town board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the north boundary thereof;

The Council of the City of Slayton, Minnesota, ordains:

Section 1. The City Council hereby determines (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the City limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, or borough.

Section 2. Territory Annexed. The corporate limits of the City are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

East 110 feet of Lot Six(6) of Sampson and French Subdivision of the South Half of the Southwest Quarter of Section Ten (10), Township One Hundred Six North (106N), Range Forty-one West (41W), located in Murray County, Minnesota.

AND:

A tract of land located in Murray County, Minnesota, described as follows: Beginning at the Southwest corner of Lot 5 in Subdivision of the S2SW2 of Section 10-106-41, and running thence north along the West line of said Lot 5, a distance of 80 rods; thence East along the North line of Lot 5, a distance of 100 feet; thence South a distance of 80 rods; and thence West along the South line of said Lot 5, a distance of 100 feet to the place of beginning, EXCEPTING THEREFROM A TRACT OF LAND DESCRIBED AS FOLLOWS: That part of Lot Five (5) in Sampson and French Subdivision of the South Half ( $S_2$ ) of the Southwest Quarter (SW2) of Section Ten (10), Township One Hundred Six North (T106N), Range Forty-one West (R41W), described as follows: A tract of land beginning at the Southwest corner of said Lot Five (5) in Sampson and French Subdivision of the Southwest Quarter (SWZ) of Section Ten (10), Township One Hundred Six North (T106N), Range Forty-one West (R41W), and running along and upon the South line of said Lot Five (5) a distance of Twenty (20) feet to the point of beginning, thence East from said point of beginning a distance of Eighty (80) feet along and upon the South line of said Lot Five (5), thence North a distance of Two Hundred Fifty (250) feet, thence West a distance of Eighty (80) feet, thence South Two Hundred Fifty (250) feet to the point of beginning and there terminating.

Section 3. Repeal. Ordinance No. 137 adopted by the City Council April 5th, 1976, and entitled "An Ordinance Extending the Corporate Limits of the City of Slayton, Murray County, Minnesota, to Include Certain Unincorporated Platted Land Abutting the City Limits", is repealed.

Section 4. Filing. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, the Town Glerk, and the County Auditor.

Section 5. Effective Date. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 4.
