ORDINANCE NO. 293

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF  
STAPLES AND INCORPORATING ADDITIONAL TERRITORY THEREIN.

The City Council of the City of Staples does ordain as  
follows:

Section 1.

The following described real estate is 60% or more bordered by  
the City of Staples, and a notice of intent to annex said real estate has  
been served upon Staples Township, pursuant to Minnesota Statutes Section  
414.033(3), and no objections by said township were received by the City  
of Staples within the required 60-day period:

All that part of the North Half of the Northwest Quarter  
(N $\frac{1}{2}$  of NW $\frac{1}{4}$ ) of Section 1, Township 133 North, Range 33  
West described as follows: Beginning at the northwest  
corner of said section, thence South on the west line of  
said section to its intersection with the south line of  
Judicial Ditch No. 8 (now under the jurisdiction of Todd  
and Wadena Counties), thence northeasterly and easterly  
on said south ditch line to its intersection with the  
centerline of 4th Street, thence northerly on said center-  
line to its intersection with the north line of Section 1,  
Township 133 North, Range 33 West, thence westerly on said  
north line to the point of beginning, except parts already  
within the city limits of the City of Staples (Todd County,  
Minnesota); together with all abutting roads and streets.

Section 2.

The City Council hereby determines that the annexation would  
be to the best interests of the City of Staples, Minnesota and of the  
territory affected, and that the land is urban in character and is so  
conditioned as properly to be subjected to city government.


Section 3.

Therefore, the City of Staples, Minnesota hereby ordains and  
declares that the property hereinbefore described be, and the same hereby  
is, annexed to, and included in the City of Staples, Minnesota as effectually  
as if it had originally been a part thereof.

Section 4.


This ordinance shall be final and shall take effect and be in
