THE CITY COUNCIL OF THIEF RIVER FALLS, MINNESOTA, ORDAINS:

Section 1: WHEREAS, the sole owner of the following described premises situated
in the County of Pennington and State of Minnesota, to-wit:

A parcel of land which is part of the N $\frac{1}{2}$ of the NE $\frac{1}{4}$, Section 32, T. 154 N.,
R. 43 W. bounded as follows:

Beginning at the Northeast corner of said Section 32; thence South along the
East line of said Section 32 to an intersection with the centerline of Trunk
Highway #1 and #59; thence Northwesterly along said centerline parallel to
and 75 feet Southwesterly of the Southwesterly line of Block 1 of Noper's
Second Addition to Thief River Falls to an intersection with the North line of
said Section 32; thence East along said North line to the point of beginning;
containing 18.4 acres more or less,

has petitioned to the City Council to have such land included within the City Limits
of the City of Thief River Falls and has filed copies of said Petition with the
Municipal Board of the State of Minnesota, with the Town Board of the Township of
North of the County of Pennington and State of Minnesota and with the County Board of
the County of Pennington, State of Minnesota, and

WHEREAS, the above described property abuts upon the boundaries of the City
of Thief River Falls, and

WHEREAS, no objections to the proposed annexation have been submitted,

NOW, THEREFORE, It is hereby determined that the annexation of said premises
will be to the best interests of the City of Thief River Falls and of the territory
affected and the above described premises are hereby declared annexed to the City of
Thief River Falls.

Section 2. City Code Chapter 20, Listing of Uncoded Annexation Ordinances is
hereby amended by addition of the foregoing ordinance to such listing.

Section 3. This ordinance shall be in force and effect from and after its
passage, approval, publication and filing with the Municipal Board, the Town Clerk
of North Township, the Pennington County Auditor, and the Secretary of State of the
State of Minnesota.
