ORDINANCE NO. 55  
AN ORDINANCE TO ANNEX TO THE  
CITY OF WARREN CERTAIN UNPLATTED  
LANDS OWNED BY WARREN LAUNDROMAT

The City Council of the City of Warren, Warren, Minnesota, does ordain as follows:

1. Certain real estate described as the Southerly 125 feet of the Westerly 192 feet of the Northeast Quarter (NE $\frac{1}{4}$ ) of Section Thirty-six (36) in Township One Hundred Fifty-five (155) North, of Range Forty-eight (48) West, is owned by Warren Laundromat, a partnership consisting of Kenneth S. Nelson and Gordon Oien and the City Council has determined that the annexation of said real estate will be to the best interest of the City of Warren and of said described land.
2. That said real estate abuts on the City of Warren and is not included in any other municipality.
3. The City of Warren hereby ordains and declares that the real estate described as the Southerly 125 feet of the Westerly 192 feet of the Northeast Quarter (NE $\frac{1}{4}$ ) of Section Thirty-six (36) in Township One Hundred Fifty-five (155) North, of Range Forty-eight (48) West, Marshall County, Minnesota, be and the same hereby is annexed to and included in the City of Warren, Warren, Minnesota, as effectively as if it had originally been a part thereof.
4. This ordinance shall be final and shall be effective upon its publication and after filing of the copy of the ordinance with the Minnesota Municipal Commission, the Town Clerk, the County Auditor, and the Secretary of State.
