ORDINANCE NO. 663

An Ordinance Extending the Corporate Limits of the City of Willmar, a Municipal Corporation of the State of Minnesota, to Include Certain Lands Owned by the City of Willmar, and Repealing Portions of Ordinance No. 606.

WHEREAS, The following described land is owned by the City of Willmar, Minnesota, and

WHEREAS, Said property abuts upon the City and is so conditioned as to be properly subject to City Government and since annexation thereof will be in the best interests of the City of Willmar and of the property to be annexed.

NOW, THEREFORE, BE IT ORDAINED, By the City Council of the City of Willmar as follows:

Section 1. *Annexation.* The following described property is hereby annexed and included within the City of Willmar, Minnesota, as effectually as if it had originally been a part thereof:

That part of Kandiyohi County, Minnesota, described as follows, to-wit:

South Half of the Southwest Quarter ($S\frac{1}{2}$ of the $SW\frac{1}{4}$), Section 17, Township 119, Range 35, EXCEPTING THEREFROM the west twenty-five (25) rods of the south thirty-six (36) rods thereof.

That part of the Northeast Quarter of the Southwest Quarter of Section 17, Township 119, Range 35, described by metes and bounds as follows, to-wit: Beginning at the Southwest corner of the Northeast Quarter of the Southwest Quarter of said Section 17; thence Easterly along the South line of the Northeast Quarter of the Southwest Quarter of said Section 17 to the Southeast corner of the Northeast Quarter of the Southwest Quarter of said Section 17; thence 200 feet North along the East line of the Northeast Quarter of the Southwest Quarter of said Section 17; thence Northwesterly to a point on the West line of the Northeast Quarter of the Southwest Quarter of said Section 17 which point is 650 feet North of the Southwest corner of the Northeast Quarter of the Southwest Quarter of said Section as measured along the West line of the Northeast Quarter of the Southwest Quarter of said Section 17; thence 650 feet South along the West line of the Northeast Quarter of the Southwest Quarter of said Section 17 to the point of beginning, containing approximately 12.9 acres.

Northwest Quarter of Southwest Quarter ($NW\frac{1}{4}$ OF $SW\frac{1}{4}$), Section 17, Township 119, Range 35, EXCEPTING THEREFROM the following parcels, to-wit:

- (1) That part of the Northwest Quarter of the Southwest Quarter of Section 17, Township 119, Range 35 lying North and West of the Center line of County Ditch No. 10 located in the Northwest Quarter of the Southwest Quarter of said Section 17, containing approximately 3.5 acres, and

(2) That part of the Northwest Quarter of the Southwest Quarter of Section 17, Township 119, Range 35, described by metes and bounds as follows, to-wit: Beginning at the Northeast corner of the Northwest Quarter of the Southwest Quarter of Section 17, Township 119, Range 35, thence South along the East line of the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of said Section 17 to a point 650 feet North of the Southeast corner of said Northwest Quarter of the Southwest Quarter of said Section 17; thence Northwesterly along a line (which line if projected Northwesterly would intersect the West line of said Section 17 a distance of 150 feet South of the Northwest corner of the Southwest Quarter of said Section 17) to the Center line of said County Ditch No. 10; thence Northeasterly along the Center line of County Ditch No. 10 to a point where the Center line of said Ditch intersects the North line of the Northwest Quarter of the Southwest Quarter; thence Easterly along the North line of said Northwest Quarter of the Southwest Quarter of said Section 17 to the Northeast corner of the Northwest Quarter of the Southwest Quarter of said Section 17, which point is the point of beginning containing approximately 8.8 acres.

Section 2. *Best Interest of the City of Willmar.* That the annexation will be to the best interest of the City of Willmar, Minnesota, and the territory affected.

Section 3. *Abuts on City Limits.* That the property above described abuts on the city limits and is conditioned as property to be subject to City Government.

Section 4. *Zoning of Above Area.* The area above described shall be zoned as follows:

I-1—Industrial Park District.

Section 5. *Effective Date.* This Ordinance shall take effect and be in full force and effect from and after the filing of a copy of this ordinance with the Minnesota Municipal Commission, the Town Clerk of Willmar Township, the County Auditor of Kandiyohi County and the Secretary of State of the State of Minnesota, and from and after its passage and publication.

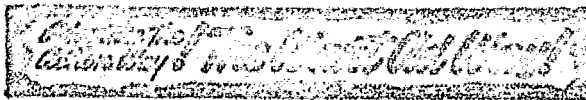
