ORDINANCE NO. 276

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WINDOM, MINNESOTA TO INCLUDE CERTAIN UNINCORPORATED TERRITORY BORDERED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village or borough; and

WHEREAS, 60% or more of the perimeter of this territory is bordered by lands already included within the corporate limits of the City of Windom and is deemed to be urban in character; and

WHEREAS, said territory is approximately 21 acres in area; and

WHEREAS, on May 25, 1977 the City caused notice of intent to annex said territory to be duly served upon the Town Board of Great Bend Township; and

WHEREAS, on June 20, 1977 the Town Board of Great Bend Township approved of said annexation and waived the 60-day waiting period in which to voice objections to said annexation.

BE IT ORDAINED BY THE CITY OF WINDOM, MINNESOTA AS FOLLOWS:

1. The City Council hereby determines that the annexation will be to the best interest of the City and to the territory affected and that none of the territory is now included within the corporate limits of any other city, village or borough.

2. The corporate limits of the City of Windom, Minnesota are hereby extended to include the unplatted territory in Great Bend Township, Cottonwood County, Minnesota, as follows; 60% or more of the perimeter of which territory is bordered by territory already included within the city limits:

All that part of the Southwest Quarter of the Southeast Quarter of Section 23, Township 105, Range 36 described as follows:

Beginning at the Southeast corner of said Southwest Quarter of the Southeast Quarter and running thence North on and along the East line of the Southwest Quarter of the Southeast Quarter of said Section 23 a distance of 1,000 feet; thence West and parallel with the South line of said Section 23 a distance of 1,310 feet more or less to the West line of the Southeast Quarter of said Section 23; thence South on and along the West line of said Southeast Quarter a distance of 120 feet more or less to the point of intersection between said quarter line and the Northeasterly line of Block 5 of Kalash Addition to the City of Windom; thence Southeasterly on and along said Northeasterly line of Block 5, Kalash Addition to the City of Windom, a distance of 1,235 feet more or less to the South line of Section 23; thence East on and along the South line of said Section 23 a distance of 440 feet more or less to the point of beginning, containing 21 acres, more or less.

Adopted by the City Council of Windom, Minnesota, this 5th day of July, 1977.
