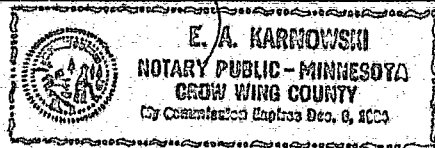

An Ordinance for the Annexation of
Government Lot 8 of Section 25, Township 47, Range 29,
Crow Wing County, Minnesota
To
The City of Cuyuna

The Council of the City of Cuyuna ordains as follows:

1. Jim Kimball, Inc. and Joseph W. Ryan, as the sole owners of all of Government Lot 8 of Section 25, Township 47, Range 29, Crow Wing County, Minnesota, located in the Town of Wolford, which Government Lot 8 does not lie within nor abut upon any other municipality, duly petitioned the City of Cuyuna to annex the said Government Lot 8 into the City.
2. Said Government Lot 8 is urban in nature and not rural.
3. As required by statute, a copy of the petition was filed on November 19, 1977, with the Minnesota Municipal Board, County of Crow Wing, Town of Wolford, and the City of Cuyuna.
4. The Town of Wolford has not submitted written objections to the annexation of Government Lot 8, and the 60 days provided by law within which to make such objections has expired.
5. Government Lot 8 of Section 25, Township 47, Range 29, Crow Wing County, Minnesota, is hereby annexed to the City of Cuyuna.
6. This ordinance shall be in force upon its publication.
