## ORDINANCE NO 76

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF LESTER PRAIRIE TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LANDS NOT EXCEEDING 200 ACRES ABUTTING THE CITY LIMITS.

WHEREAS, a certain Petition dated November 30, 1977, requesting annexation of territory hereinafter described was duly presented to the City Council on the 12th day of December, 1977; and

WHEREAS, the quantity of land embraced within the area described in the Petition and bounded as described, is less than one hundred acres of unplatted land and no part of which is included within the limits of an incorporated city, village or burough; and

WHEREAS, the Petition was signed by all of the owners of said land; and

WHEREAS, no objection to the annexation has been received from the County Board, or the governing body of any municipality whose boundaries abut the boundaries of the land to be annexed; the Town Board has consented to said annexation; and the Municipal Board has permitted the City to proceed; and

WHEREAS, no hearing is required by law on the proposed annexation; and

WHEREAS, the land described in the Petition abuts the City limits of the City of Lester Prairie; and therefore, the Council of the City of Lester Prairie, Minnesota ordains:

Section 1

(1) That the annexation will be to the best interests of the City and the territory affected;

(2) That the territory described herein abuts upon the City limits and is urban or suburban in character; and

(3) That none of the said territory is included within the limits of any city, village or burough.

Section 2 - Territory Annexed

The corporate limits of the City are hereby annexed to the unplatted land described as follows, and the same is hereby annexed to and included within the City as effectually as if it orginally had been a part thereof:

The Southeast Quarter of the Southeast Quarter of Section Two (2) Township One Hundred Sixteen (116) Range Twenty-Seven (27) West, except the North Eighteen (18) rods thereof.

And also the following tract:

The North Five Hundred (500) feet of the East Half of the Northeast Quarter of Section Eleven (11), Township One Hundred Sixteen (116) Range Twenty-Seven (27) West.
