ORDINANCE NO. 76-1

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF LINDSTROM, MINNESOTA, TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain Petition dated December 30, 1975, requesting annexation of certain territory was duly presented to the Council on the 8th day of January, 1976, and

WHEREAS, the quantity of land embraced within the area described in the Petition and bounded as described is approximately 1½ acres of platted land, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the Petition was signed by all of the owners of the land proposed to be annexed as hereinafter described, and

WHEREAS, the land described in the Petition abuts upon the City limits at the northerly boundary thereof; and

WHEREAS, copies of said Petition have been filed with the Municipal Commission, the Town Board of the Town of Chisago Lake, and the Chisago County Board of County Commissioners, said Town and County being the Town and County in which all of the land proposed to be annexed is located, and

WHEREAS, the boundaries of no other municipality abut upon the boundaries of the land to be so annexed, and

WHEREAS, no written objections to said annexation have been submitted to the Municipal Commission or the City of Lindstrom by the Chisago Lake Town Board or the Chisago County Board of Commissioners within sixty (60) days after said filing and the time allowed pursuant to law, and

WHEREAS, no Petition for incorporation or annexation is pending before the Municipal Commission including all or any part of the land proposed to be annexed and herein described.

The Council of the City of Lindstrom ordains:

Section 1. The City Council hereby determines (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the City Limits and is urban in character; and (3) that none of said territory is now included within the limits of any incorporated city, village or borough and is platted, and does not exceed 200 acres.

Section 2: Territory annexed. The corporate limits of the City are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

That part of Lot 9 of the recorded plat of Currie Beach, Chisago County, described as follows:

Beginning at the southeast corner of said Lot 9; thence North along the east line of Lot 9 a distance of 220 feet; thence West at right angles a distance of 226 feet; thence South parallel with the east line of Lot 9 to the South line of Lot 9; thence northeasterly along the South line of Lot 9 to the point of beginning.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, the County Auditor of Chisago County, Minnesota, and the Town Clerk of the Town of Chisago Lakes.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 3.
