ORDINANCE NO. 37

AN ORDINANCE ANNEXING LANDS TO THE CITY OF ORONOCO

WHEREAS, on September 22, 1977, all of the landowners of the real property hereinafter described, which is adjacent to the City limits, have petitioned for annexation of said land pursuant to M.S. Sec. 414.033(5) and

WHEREAS, said land is unplatted and contains less than 200 acres, and

WHEREAS, copies of said petition have been duly filed with the Municipal Commission, the Oronoco Town Board and the Olmsted County Board, and

WHEREAS, the Oronoco Town Board has in writing waived its right to a hearing and stated that it has no objection to the annexation, and

WHEREAS, the City Council has determined that said annexation is in the best interests of the City of Oronoco and the land affected,

The City Council of Oronoco hereby ordains that the following described land:

A part of the North Half of the Northeast Quarter of Section 17, Township 108 North, Range 14 West, described as follows:

Beginning at the Northwest corner of the Northeast Quarter of said Section 17; thence South 01°50'23" East, assumed bearing, along the West line of said Northeast Quarter, thence 909.10 feet to a point which is 404.50 feet North of the Southwest corner of the North Half of said Northeast Quarter; thence North 89°16'37" East, 1.75 feet; thence southeasterly 160.73 feet along a tangential curve concave to the Southwest, central angle 31°23' radius 293.44 feet, and the chord of said curve bears South 75°01'53" East, 158.73 feet; thence South 59°20'23" East, tangent to said curve, 681.71 feet to the South line of the North Half of said Northeast Quarter; thence North 88°46'01" East along said South line, 336.06 feet; thence North 0°29'39" East 561.01 feet; thence North 38°29'21" East 345.00 feet; thence North 51°30'39" West, 180.00 feet; thence northwesterly 18.85 feet along a tangential curve concave to the Southwest, central angle 9°00', radius 120.00 feet, and the chord of said curve bears North 56°00'39" West, 18.83 feet; thence North 29°29'21" East, 370.00 feet; thence North 01°30'39" West, 50.00 feet to the North line of said Northeast Quarter; thence South 88°29'21" West, along said North line, 1350.96 feet to the point of beginning.

Containing 31.58 acres,

is hereby declared annexed to the City of Oronoco. A copy of this Ordinance shall be filed with the Municipal Commission, the Oronoco Town Clerk, the Olmsted County Auditor and the Minnesota Secretary of State and recorded in the Olmsted County Recorder's office.

Adopted by the Council this Oct day of 31st, 1977.
