ORDINANCE NO. 545

AN ORDINANCE DETERMINING THE ANNEXATION OF CERTAIN LAND TO BE IN THE BEST INTERESTS OF THE CITY OF STILLWATER AND OF THE TERRITORY AFFECTED AND DECLARING THE SAME TO BE ANNEXED TO THE CITY.

Section 1. The following territory, consisting of unplatted land not exceeding two hundred (200) acres in all, abutting upon the City of Stillwater, Washington County, Minnesota, being so conditioned as property to be subject to municipal government and not included in any other municipality, upon petition of the owners of said land, and in the best interest of the City of Stillwater and of said territory, is hereby declared to be annexed to said City, to-wit:

All that part of the following described land lying Southerly of a straight line drawn between Point A and Point B as said points are designated in the following description:

All that part of the Northeast Quarter (NE¹/₄) of Section Thirty-two (32), Township Thirty (30) North, Range Twenty (20) West, in the City of Stillwater, Minnesota, described as follows:

Commencing at the northeast corner of Section Thirty-two (32), Township Thirty (30) North, Range Twenty (20) West, Washington County, Minnesota; thence on an assumed bearing of North 89°51'00" West along the Northline of said Section Thirty-two (32), for 1694.70 feet; thence South 6°00'00" East for 741.30 feet; thence South 0°13'00" West for 48.30 feet to the point of beginning of this description; thence continuing South 0°13'00" West for 157.13 feet; thence South 22°47'00" East for 221.93 feet to a point, said small point being Point A, thence continuing along the same line South 22°47'00" East for an additional 100 feet; thence North 67°13'00" East for 149.86 feet; thence South 26°02'00" East for 140.00 feet; thence North 63°58'00" East for 145.00 feet; thence South 26°02'00" East for 77.48 feet to a small point, said point being Point B, thence North 63°58'00" East for 80.00 feet; thence North 83°28'00" East for 150.00 feet; thence North 6°32'00" West for 117.83 feet; thence North 39°48'00" West for 172.00 feet; thence North 44°02'00" West for 360.73 feet; thence North 3°57'00" East for 69.90 feet; thence South 89°48'00" West for 168.60 feet; thence South 6°18'00" East for 101.36 feet; thence North 89°51'00" West for 180.00 feet to the point of beginning.

Section 2. The above described territory shall be incorporated in and become a part of the Fourth ward (First Precinct) of the City of Stillwater for the purposes of elections until otherwise designated by the City Council as provided by law.

Section 3. This ordinance shall be in full force and effect from and after its passage and publication, and the annexation provided for herein shall be deemed final upon filing a copy thereof with the Minnesota Municipal Commission, the Washington County Auditor, and the Secretary of State.
