Ordinance No. 201

Chatfield

AN ORDINANCE ANNEXING CERTAIN LAND TO THE
CITY OF CHATFIELD, MINNESOTA.

The Council of the City of Chatfield, Minnesota, does ordain:

1. That the following described lands, situate in the West half of the Northeast quarter of section 31, township 105 North, range 11 West, Olmsted County, Minnesota, are hereby annexed to the City of Chatfield, Minnesota, to-wit:

The West 800 feet of the North one half of the Northeast Quarter of Section 31, Township 105 North, Range 11 West, Olmsted County, Minnesota less the North 765 feet of the East 592 feet of the West 800 feet of the North one half of said Quarter Section, and less the North 900 feet of the West 208.00 feet of the North 1050.00 feet of the Northwest Quarter of the Northeast Quarter of Section 31, Township 105 North, Range 11 West, Olmsted County, Minnesota.

The West 800 feet of the North 13 acres of the Southwest Quarter of the Northeast Quarter of Section 31, Township 105 North, Range 11 West, Olmsted County, Minnesota, less the following described tract of land:

A Tract of land in the Southwest Quarter of the Northeast Quarter of Section 31, Township 105 North, and Range 11 West, described as follows: Commencing at the Southwest corner of the Southwest Quarter of the Northeast Quarter and running thence north by 00 degrees, 05 minutes, 00 seconds West, on an assumed bearing along the West line of said Southwest Quarter of the Northeast Quarter, for a distance of 20.00 feet, for a place of beginning; running thence South by 89 degrees, 43 minutes, 00 seconds East for a distance of 1301.19 feet, to the East line of said Southwest Quarter of the Northeast Quarter; thence North by 00 degrees, 02 minutes, 30 seconds West, along said East line for a distance of 185.03 feet; thence North by 89 degrees, 43 minutes, 30 seconds West for a distance of 1301.28 feet, to a point 20.00 feet East of the West line of said Southwest Quarter of the Northeast Quarter; thence South of 00 degrees, 05 minutes, 00 seconds East for a distance of 184.63 feet, to the place of beginning.

2. That, upon approval of this Ordinance by the Minnesota Municipal Commission, all plats inconsistent with this Ordinance shall be altered and modified to the extent of such inconsistency, but no farther.
