ORDINANCE NUMBER

AN ORDINANCE ANNEXING CERTAIN LAND TO THE CITY-OF-WAITE PARK, IN STEARNS COUNTY, MINNESOTA.

WHEREAS, a certain petition having been duly filed with the City Council in and for the City of Waite Park, in Stearns County, Minnesota, by the sole owner of certain real estate situate in the County of Stearns and State of Minnesota, described as follows, to-wit:

All that part of the Northeast Quarter (NE%) of Section Twenty (20), Township One Hundred Twenty-four (124) North, Range Twenty-eight (28) West, Stearns County, Minnesota, lying Southerly of the centerline of County Road #137; less and except the plat of "CLOUD PARK"; on file and of record; also less and except the North 208.71 feet of the East 313.07 feet of the West 346.17 feet, lying Southerly of the centerline of County Road #137, thereof. Said tract containing 33.3 acres, more or less.

That part of the Northwest Quarter of Section 20, Township 124 North, Range 28 West, Stearns County, Minnesota, described as follows:
Commencing at the northwest corner of said Section 20; thence \$89°35'35'E on an assumed bearing along the north line of said Section 20 a distance of 863.26 feet to the point of beginning of the tract to be described; thence continue \$89°35'35'E along said north line 1,216.68 feet to a point distant 566.60 feet west of the northeast corner of said Northwest Quarter; thence \$00°17'10'W parallel with the east line of said Northwest Quarter 466.60 feet; thence \$89°35'35'E 566.60 feet to the east line of said Northwest Quarter; thence \$00°17'10'W along the east line of said Northwest Quarter; thence \$00°17'10'W along the east line of said Northwest Quarter 1,085.29 feet to the centerline of County Road #137; thence \$35°42'07'W along centerline 740.26 feet; thence southwesterly 484.12 feet along said centerline and along a tangential curve, concave to the southeast having a radius of 2,247.00 feet and a central angle of 12°20'40"; thence \$73°21'27'W tangent to said curve along said centerline 860.72 feet; thence southwesterly 233.36 feet along said centerline and along a tangential curve, concave to the southeast having a radius of 3,800.79 feet and a central angle of 03°31'04"; thence N00°19'59'E along a line 391.20 feet east of, measured at right angles to and parallel with the west line of said Section 20 a distance of 1,260.48 feet; thence \$89°35'35'E parallel with the north line of said Section 20 a distance of 472.06 feet; thence N00°19'59'E 770.88 feet to the point of beginning. Subject to the right-of-way of a Township Road over the most easterly 33 feet thereof and the right-of-way of said County Road #137 and any easements of record.

petitioning that said real estate be annexed to the City of Waite Park, Minnesota, and,

WHEREAS, it was determined by said City Council that said property owner who signed said petition is the sole owner of said property above described, and that said property consists of less than 200 acres, and abuts upon the boundaries of the City of Waite Park, and,

WHEREAS, upon receipt of said petition said City Council filed copies of the same with the Minnesota Municipal Commission, the Township Board of St. Cloud and the Stearns County Board, and within sixty (60) days of said filing the Township Board of St. Cloud filed written obejction to said annexation, and,

WHEREAS, at a meeting held on January 16, 1978 the Township Board of St. Cloud withdrew its objection to said annexation and filed the same with the Minnesota Municipal Board, and

WHEREAS, it has been determined by said City Council that said annexation will be in the best interest of the City of Waite Park and the above described property.

NOW, THEREFORE, the City Council in and for the City of Waite Park does hereby declare and ordain:

That the corporate limits of the City of Waite Park, in Stearns County, Minnesota, be and they hereby are extended to include that certain real estate hereinbefore described, and the same is hereby annexed and included in the City of Waite Park as effectually as if it had originally been a part thereof.

IT IS FURTHER ORDAINED, that the City Clerk file certified copies of this ordinance with the Minnesota Municipal Board, the Stearns County Auditor and the Secretary of State of the State of Minnesota.

This ordinance shall become effective from and after its passage, publication and filing of certified copies as hereinbefore directed.
