AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF CAMBRIDGE, ISANTI COUNTY, MINNESOTA, TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA

WHEREAS, a certain petition dated September 30, 1977, requesting annexation of the territory described below, was duly presented to the council and filed in the office of the City Clerk on 1977; and

WHEREAS, said petition for annexation was duly signed by all of the owners of the property described below pursuant to the statutes made and provided in such cases; and

WHEREAS, a true and correct copy of said Petition for Annexation was filed in the office of the Township Clerk of the Township of Cambridge on October 25, 1977, in the office of the County Auditor in and for Isanti County, Minnesota, on October 25, 1977 (the said Township and County being the same in which all of the lands to be annexed is located); and with the Minnesota Municipal Commission on October 25, 1977; and

WHEREAS, more than sixty (60) days have elapsed since said Petition has been filed with the said Cambridge Township, Auditor of Isanti County, and Minnesota Municipal Commission, and no written objections to the annexation from any municipal subdivision or person has been filed or submitted to the City of Cambridge or the Minnesota Municipal Commission; and
