AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF NICOLLET TO INCLUDE 1.36 ACRES OF LAND LOCATED IN SECTION 3, TOWNSHIP 109 NORTH, RANGE 28 WEST.

The City Council of the City of Nicollet ordains:

Section 1: An application for annexation has been filed with the governing body of the City of Nicollet, Minnesota by all of the owners of the land petitioning the following described real estate to be annexed to the City of Nicollet, Minnesota, to-wit:

> That part of the Southwest Quarter of Section 3, Township 109 North, Range 28 West described as:

Beginning at a point on the East line of the Southwest quarter of Section 3 where said line intersects drainage ditch in said Southwest quarter; the point of intersection being 876.70 feet North of the South quarter corner of Section 3; thence North 01 degrees 07 minutes 18 seconds East (assumed bearing) along the East line of the Southwest quarter of Section 3, a distance of 267.30 feet; thence North 86 degrees 07 minutes 12 seconds West, 409.2 feet to a point on the centerline of the drainage ditch; thence South 54 degrees 59 minutes 42 seconds East along said centerline (the same being the northeasterly line of Becker's Fourth Addition) a distance of 244.67 feet; thence South 39 degrees 07 minutes 0 seconds East along said ditch centerline, 199.24 feet; thence North 90 degrees 00 minutes 00 seconds East along said ditch centerline, 76.89 feet to the point of beginning. Containing 1.36 acres, subject to an easement for roadway purposes over and across the easterly boundary.

Section 2: The area petitioned for annexation is unplatted.

Section 3: An affidavit has been filed in the office of the City Clerk stating that copies of the Petition for Annexation have been filed with the Minnesota Municipal Commission, the Town Board of Nicollet Township and the County Board of Nicollet County in which all of the land to be annexed is located. More than sixty (60) days have elapsed since said filing without objection to said annexation being received by the Commission or the

City; and in fact, the Town Board of Nicollet Township and the County Board of Nicollet County have specifically approved said Petition for Annexation.

Section 4: The annexation will be to the best interests to the City of Nicollet.

Section 5: The corporate limits of the City of Nicollet is hereby extended to include the property described in Section 1, and the same is hereby annexed to and included within the City as effectively as if it had originally been a part thereof.

Section 6: The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, the Nicollet County Auditor and the Nicollet Township Clerk.
