ORDINANCE NO. 682

An Ordinance Extending the Corporate Limits of the City of Willmar, A Municipal Corporation of the State of Minnesota, To Include Certain Lands Not Exceeding 200 Acres.

WHEREAS, A petition has been filed with the governing body of the City of Willmar, a municipal corporation of the State of Minnesota, by the sole owners having an interest therein, to have certain real property hereinafter described included within the limits of the City of Willmar, Minnesota, and

WHEREAS, It is proposed to annex by virtue hereof to the said City of Willmar, said property, all of which said property is in Kandiyohi County, State of Minnesota, and

WHEREAS, The said property to be annexed consists of approximately 21.7 acres, more or less, described as follows, to-wit:

All that part of the SW $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 12 lying Northerly and Westerly of the Westerly right of way line of Burlington Northern Railway Company St. Cloud Branch Line, and all that part of the NW $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 12 lying Northerly and Westerly of the Westerly right of way line of Burlington Northern Railway Company St. Cloud Branch Line except the East 720 feet of the West 753 feet of the North 415 feet and also except the East 400 feet of the West 433 feet of the Southerly 165 feet of the Northerly 580 feet, all in Township 119, Range 35.

NOW, THEREFORE, The City Council of the City of Willmar hereby determines, ordains and declares as follows:

SECTION 1. BEST INTEREST OF THE CITY OF WILLMAR AND AREA TO BE ANNEXED. That the annexation will be to the best interests of the City of Willmar, Minnesota, and of the territory affected.

Section 2. ABUTS ON CITY LIMITS. That the property above described abuts on the City limits, and is so conditioned as property to be subject to City government.

Section 3. ANNEXATION. That the said property is hereby annexed to, and included within, the City of Willmar, Minnesota, as effectually as if it had originally been a part thereof.

Section 4. ZONING. The area above described shall be zoned I-2, Light Industrial District.

Section 5. EFFECTIVE DATE. This ordinance shall be filed and shall take effect and be in full force and effect from and after filing a certificate thereof with the Minnesota Municipal Commission, the County of Kandiyohi, Minnesota, and the Secretary of State of the State of Minnesota, and from and after its passage and publication.
