state Highway No. 94; thence West along the South right-of-way line of said Interstate Highway 94 to a point of intersection with the West right-of-way line of the Burlington Northern Railroad Breckenridge line; thence South along said West right-of-way line of said Burlington Northern Breckenridge line to a point of intersection with the East West half section line dividing said Section 21; thence East along said half section line to the Southwest corner of said Village Green Addition; thence North along the West line of said Village Green Addition to the point of beginning, containing 9.5 acres more or less.

Section 3. FILING. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor for Clay County.

Section 4. EFFECTIVE DATE. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village, or borough; and

WHEREAS, this territory is bordered on at least sixty percent (60%) of its boundaries by lands already included within the corporate limits of the City of Moorhead and is deemed to be urban in character; and

WHEREAS, due notice is properly given to the Town Board of Moorhead Township that the City of Moorhead intended to annex the below described land pursuant to M.S.A. 414.03, Subdivision 2, and no objections to the annexation have been received and more than sixty (60) days has elapsed from the service of this notice upon the Town Board,

NOW, BE IT ORDAINED by the City Council of the City of Moorhead, as follows:

Section 1. The City Council does hereby determine (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the City limits and is urban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.
