





ORDINANCE NO. 596

ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY
OF MOORHEAD TO INCLUDE CERTAIN UNINCORPORATED TERRITORY
BORDERED ON SIXTY PERCENT OF ITS BOUNDARIES BY LAND
WITHIN THE CITY LIMITS AND ABUTTING THEREON

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village, or borough; and

WHEREAS, this territory is bordered on at least sixty percent (60%) of its boundaries by lands already included within the corporate limits of the City of Moorhead and is deemed to be urban in character; and

WHEREAS, due notice is properly given to the Town Board of Moorhead Township that the City of Moorhead intended to annex the below described land pursuant to M.S.A. 414.03, Subdivision 2, and no objections to the annexation have been received and more than sixty (60) days has elapsed from the service of this notice upon the Town Board,

NOW, BE IT ORDAINED by the City Council of the City of Moorhead, as follows:

Section 1. The City Council does hereby determine (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the City limits and is urban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. TERRITORY ANNEXED. The corporate limits of the City of Moorhead, Minnesota, are hereby extended to include the unplatted territory described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof, which territory now is and has heretofore been bordered on at least sixty percent (60%) of its exterior boundary by territory already included within the City limits:

All that part of Section Twenty-one (21), Township 139 North (Moorhead Township), Range 48 West, Clay County, Minnesota, described as follows: Commencing at the Northwest corner of Village Green Addition to the City of Moorhead, thence North along the northward extension of the West line of Village Green Addition to the City of Moorhead to a point of intersection with the South right-of-way line of Federal Aid Inter-
