ORDINANCE NO. 609 AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MODERAD TO INCLUDE CERTAIN UNINCORPORATED TERRITORY BORDERED ON THREE SIDES BY LAND WITHIN THE CITY LIMITS AND ABUITING THEREON.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village, or borough, and

WHEREAS, this territory is bordered on at least sixty percent(60%) of its boundaries by lands already included within the corporate limits of the City of Moorhead and is deemed to be urban in character; and

WHEREAS, due notice was properly given to the Town Board of Moorhead Township and to the Town Board of Oakport Township that the City intended to annex the below described land pursuant to M.S.A. 414.03, Subdivision 2, and no objections to the annexation have been received and more than sixty(60) days has elapsed from the service of this notice upon the Town Board,

NOW, BE IT ORDAINED by the City Council of the City of Moorhead, as follows:

Section 1. The City Council dies hereby determine (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the city limits and is urban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. TERRITORY ANNEXED. The corporate limits of the City of Moorhead, Minnesota, are hereby extended to include the unplatted territory described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof, which territory now is and has heretofore been bordered on at least sixty percent(60%) of its exterior boundary by territory already included within the city limits:

Tract I. The West 111.4 feet of the South 195.9 feet of Auditor's Outlot 32-L, Section 32, Township 140, Range 48, Clay County, Minnesota, containing .49 acres, more or less.

Tract II. Commencing at a point on the South line of Auditor's Outlot 32-L, 111.4 feet East of the Southwest corner thereof, thence North 195 feet, thence East 131 feet, thence South 195 feet to the South line of said Auditor's Outlot 32-L, thence West 131 feet along the said South line to the point of beginning, Section 32, Township 140, Range 48, Clay County, Minnesota, containing .58 acres, more or less.

Section 3. FILING. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor for Clay County.

Section 4. EFFECTIVE DATE. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
