





This order is effective retroactive to 17 May 1978, and shall be in force until 19 May 1978.

EMERGENCY EXECUTIVE ORDER NO. 172

Providing for assistance
to officials of Ramsey
County, Minnesota

I, Rudy Perpich, Governor of the State of Minnesota, by virtue of the authority vested in me by the Constitution and applicable statutes, hereby issue this Executive Order.

WHEREAS, the St. Paul Police Department has requested assistance in the search for a lost child; and

WHEREAS, conditions of the area in which the child was lost precluded an effective search within available resources of the St. Paul Police Department:

NOW, THEREFORE, I order:

1. The Adjutant General of Minnesota to order to active duty on or after 17 May 1978, in the service of the state, such elements of the military forces of the state as required, and for such a period of time necessary to successfully complete a search for the lost child.

Acting Mayor Amundson read the following proclamation:

WHEREAS, Burglary, both in number of violations and in resultant property loss, is the leading major crime across the nation; and

WHEREAS, Burglary, all too frequently results in the injury to and death of the victim; and

WHEREAS, the success of burglary prevention and detection efforts is dependent, to a large degree, on the participation of an aroused and involved public, now

THEREFORE, I, Roger Peterson, Mayor of the City of Cottage Grove, do PROCLAIM:

That the month of June 1978, is Burglary Prevention Month and call upon all citizens to aid and assist their police department and do all else possible, to prevent, detect, and report burglary.

Councilman McHattie introduced the following resolution and moved for its adoption:

RESOLUTION NO. 78-56

RESOLUTION APPROVING SPECIFICATIONS AND DIRECTING ADVERTISEMENT FOR BIDS FOR ONE NEW OR USED TANKER TRUCK CHASSIS

WHEREAS, the Chief of the Grove-Estates Fire Department has prepared specifications for one new or used tanker truck chassis, and

WHEREAS, the Clerk has presented the hereinbefore described specifications to this Council for consideration and review, and

WHEREAS, this Council has reviewed said specifications and finds and determines that they are appropriate, now

THEREFORE, BE IT RESOLVED, by the City Council of the City of Cottage Grove, County of Washington, State of Minnesota, that the specifications for one new or used tanker truck chassis presented to this Council by the City Clerk shall be, and the same hereby are approved, and

BE IT FURTHER RESOLVED, that the Clerk shall obtain sealed bids on these specifications and that said bids shall be opened on the 6th day of June, 1978 at 10:00 a.m. C.D.T. in the Council Chambers and thereafter referred to this Council for consideration and award of the contract, and

BE IT FURTHER RESOLVED, that the Clerk shall solicit said bids by public notice inserted at least once in the official newspaper, not less than ten (10) days before the final date for submitting bids; that the Clerk shall also solicit sealed bids by sending notices by mail to all prospective bidders known to him; and shall also solicit bids by posting notice on the bulletin board at this office at least five (5) days before the final date for submitting bids; and that all bids shall be sealed when received and shall be opened in public at the hour hereinbefore stated, and all original bids, together with all documents pertaining to the award of a contract, shall be retained and made a part of the permanent file or record, and shall be open to public inspection.
