ORDINANCE NO. 1325

ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN INCORPORATED TERRITORY ATLEAST SIXTY PERCENT (60%) SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village, or borough,

AND WHEREAS, this territory is atleast sixty percent (60%) surrounded on all sides by land already included within the corporate limits of the City and is deemed to be urban in character.

THE COMMON COUNCIL OF THE CITY OF AUSTIN HEREBY ORDAIN:

SECTION 1: Territory Annexed.

The Corporate limits of the City of Austin, Minnesota, are hereby extended to include territory described as follows; which territory now is and has heretofore been atleast sixty percent (60%) surrounded by territory already included within the City limits:

Lots 2 and 18 of Block 4, Nob Hill Addition including 1/2 of the street right-of-way adjacent to these lots.

SECTION 2: Filing Period.

The City Recorder is directed to file certified copies of this ordinance with the Secretary of State, County Auditor of the County of which the property is located, the Township Clerk of the Township of which the property is located, Minnesota Municipal Commission, Austin Utilities, and Registrar of Deeds.

SECTION 3: Effective Date of Annexation.

This ordinance takes effect upon passage and publication and filing the certified copies as directed in Section 2.
