Ordinance No. 177

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF PELICAN RAPIDS TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated December 30, 1977, requesting annexation of the territory hereinafter described was duly presented to the council on the 13th day of March, 1978; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is approximately 18 acres of unplatted land, no part of which is included within the limits of an incorporated city, or borough; and

WHEREAS, the petition was signed by all owners; and

WHEREAS, no objections to the annexation have been sustained by the town board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and WHEREAS, the land described in the petition abuts upon the city limits at the Northerly boundary thereof;

The council of the City of Pelican Rapids, Minnesota, ordains:

Section 1. The city council hereby determines (1) that the annexation will be to the best interests of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, or borough.

Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the unplatted land described as follows and

the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof, said land being located in the County of Otter Tail, State of Minnesota, to-wit:

The East 430 feet of the North 200 feet of the South 2,095 feet of the Northwest Quarter of Section 22, Township 136, Range 43 West; and the East 430 feet of the said Northwest Quarter, except the South 2,095 feet thereof, and also except the North 200 feet thereof in Section 22, Township 136, Range 43 West; and the Northerly 752.5 feet of the said Northwest Quarter except the West 1,485 feet thereof and also except the East 430 feet thereof, all in Section 22, Township 136, Range 43 West.

Section 3. Filing. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the Town Clerk, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
