CHAPTER NO. 408
AN ORDINANCE ANNEXING CERTAIN LANDS TO
THE CITY OF SAUK CENTRE.

THE CITY OF SAUK CENTRE DOES ORDAIN:

Section 1. That the following described real property adjoins the the City limits of Sauk Centre and is located in the County of Stearns, State of Minnesota, to-wit:

Lot 4 of Auditor's Subdivision of the North Half of Section 15, Township 126, Range 34, which lies West of the thread of Sauk River, except the North 1 rod which lies West of Lot 3.

Section 2. That the owners of the said land, have petitioned the City to have the said land annexed, added into and made a part of the said City of Sauk Centre.

Section 3. That copies of the petition for said annexation were filed with the Town Board of Sauk Centre Township, the Auditor of Stearns County, and the Minnesota Municipal Board.

Section 4. That the Minnesota Municipal Board, by its Order dated May 25, 1978, authorized the City of Sauk Centre to annex the said land, by ordinance.

Section 5. That it will be in the best interest of the said City of Sauk Centre that the said lands be annexed into the said City, and said lands are hereby annexed, taken into, and are hereby made a part of the said City of Sauk Centre, in Stearns County, Minnesota.

Section 6. That this Ordinance will take effect and be in force thirty (30) days after its publication.

The foregoing Ordinance was duly passed and adopted at a meeting of the Council of the said City, held on the 21st day of June, 1978.
