ORDINANCE NO. 410

AN ORDINANCE FOR THE ANNEXATION OF CERTAIN LANDS INTO THE CITY OF ORTONVILLE, MINNESOTA.

The City Council of the City of Ortonville, Minnesota, does ordain:

Section 1. That it will be for the best interest of the City of Ortonville that the annexation herein be granted.

Section 2. That the following described premises abutting the municipal corporate limits of the City of Ortonville, Minnesota, be and are hereby annexed and brought within the corporate limits of the City of Ortonville, Minnesota, to-wit:

The East Twenty-Five (25) feet of Outlot One Hundred Fourteen (114)

And

Outlot One Hundred Twenty-Five (125) All located in Section 15 T 121 N - R 46 W

Section 3. This Ordinance shall be in force and effect from and after its passage and publication according to law.
