## ORDINANCE 2330

## Introduced by Councilman Harry C. Brown

## AN ORDINANCE ANNEXING A PORTION OF HAMMER ROAD AND AREA NORTH

WHEREAS, the City Council on April 10, 1978, adopted Resolution 3174, which initiated proceedings to annex to the City the property hereinafter described under provisions of Minnesota Statutes 414.033; and

WHEREAS, the quantity of land embraced within the area described is 41.23 acres of unplatted land, no part of which is included within the limits\_of an incorporated city of borough; and

WHEREAS, township officers have stated they have no objection to this annexation and have waived in writing the balance of the 90-day period during which they are entitled by law to file objections; and

WHEREAS, the Council on May 22, 1978, conducted a public hearing on the proposed annexation, written mailed notice of which was sent to all owners of property included in the territory described, and no objections were voiced at this hearing to the proposed annexation; and

WHEREAS, the land described herein abuts upon the City limits at its easterly boundaries; and

WHEREAS, more than 60 percent of the boundary of the property described herein abuts upon City limits; now, therefore,

THE CITY OF ALBERT LEA DOES ORDAIN:

Sec. 1. That the City Council hereby determines that the annexation will be in the best interests of the City and of the territory affected; that the territory described herein abuts upon the corporate limits and is or is about to become urban in character; and that none of said territory is now included within the limits of any city or borough.

Sec. 2. That the corporate limits of the City of hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City of Albert Lea as effectually as if it had originally been a part thereof:

Beginning at the S.W. Cor. Sec. 34-T103N-R21W; thence  $N89^{0}57' E$ 499.09' to the west R/W of the Chicago, Rock Island & Pacific Railroad; thence  $S07^{0}00'22'W 50.38$  along the west R/W of the Chicago, Rock Island & Pacific Railroad to the south R/W of C.R. #92 (Hammer Rd.); thence  $S89^{0}$ 57'W approximately 492.6' along the south R/W of C.R. #92; thence  $S89^{0}59'W$ approximately 1320' along the south R/W of C.R. #92; thence north along the west line of the NE¼ of the NE¼ Sec. 4-T102N-R21W 50' to the N.W. Corner of said NE¼ OF NE¼; thence  $N89^{0}59' E 100'$ ; thence 376 on a line parallel to the west line of the SE¼ of theSE¼ Sec. 33-T103N-R21W; thence west 100' on a line parallel to the south line of said ¼¼ Section to the west line of said ¼¼ Section; thence north to the N.W. Corner of said ¼¼ Section; thence east to the N.E. Corner of said ¼¼ Section; thence  $S00^{0}20'45'' E$  along the east line of Sec. 33-T103N-R21W to the point of beginning. Containing 41.23 acres.

Sec. 3. That the property described in Section 2 is hereby zoned R-1 (single family residence district and is determined to be a part of Ward 1.
