The City Council of the City of East Grand Forks, Minnesota do ordain:
Section 1. A Petition has been filed with the City Council of the City of East Grand Forks, Minnesota, by Plains Dev., Inc., shareholders of which are D.R. Gleason, John J. Gaddie, and Walter J. Mikkelson, being the owners of the land hereinniter described, to have such land included within the City limits of the City of East Grand Forks, Minnesota; that copies of said Petition were filed with the Minnesota Municipal Commission, the Town Board of Grand Forks Township and the County Board of Polk County, Minnesota; and that a waiver of objections has been resolved from the Grand Forks Township.

Section 2. That the tract of land

4. That the Petition for annexation was signed by all of the owners of the land und real estate hereinabove described.


