ORDINANCE NO. 103

AN ORDINANCE ANNEXING LANDS TO THE CITY OF GOODHUE

The City Council of Goodhue ordains that the land area contained within the following described boundaries is hereby annexed to and incorporated within the City of Goodhue, Goodhue County, Minnesota, to-wit:

That part of the Northeast Quarter and that part of the Northwest Quarter of Section 28, Township 111, Range 15, Goodhue County, Minnesota, described as follows:

Commencing at the northwest corner of said Northwest Quarter of Section 28; thence on an assumed bearing of East along the north line of Northwest Quarter of Section 28, a distance of 1223.90 feet to the northwest corner of MATTHEES 2ND ADDITION, according to the recorded plat thereof on file and of record in the office of the Goodhue County Recorder; thence on a bearing of South, along the west line of said MATTHEES 2ND ADDITION, a distance of 363.00 feet to the southwest corner thereof, being the point of beginning of land to be described; thence continue on a bearing of South, a distance of 695.68 feet; thence on a bearing of East, a distance of 1597.12 feet to the westerly line of a 100.00 foot strip of land formerly owned by the Chicago Northwestern Transportation Company; thence North 12 degrees 18 minutes 46 seconds West, a distance of 712.06 feet to the intersection with a line bearing East, from the point of beginning; thence on a bearing of West, a distance of 1445.27 feet to the point of beginning.

EXCEPT that part lying north of the south line of the North Half of the North Half of said Northwest Quarter of Section 28, and ALSO EXCEPT that part lying north of the south line of the North Half of the North Half of the Northeast Quarter of said Section 28.


