ORDINANCE NO. 138
AN ORDINANCE AMENDING ORDINANCE No. 136
ENTITLED "AN ORDINANCE ANNEXING TWO
TRACTS OF LAND TO THE CITY OF HALLOCK"

THE CITY COUNCIL OF THE CITY OF HALLOCK DOES ORDAIN:

Section 1. (a) Section II. is hereby amended by
deleting from Ordinance No. 136 the following description:

TRACT B

That part of the Southeast Quarter (SE $\frac{1}{4}$)
of Section Thirteen (13), Township One Hundred
Sixty-one (161) North, Range Forty-nine (49)
West, 5th Principal Meridian, Kittson County,
Minnesota, described as follows:

Beginning at the Northeast corner of the plat
of OSCAR NELSON'S FIRST ADDITION TO HALLOCK,
according to the recorded plat thereof; thence
South 790.00 feet along the east line of said
plat; thence W 580.00 feet along the southerly
line of said plat; thence South 246.91 feet
along the easterly line of said plat; thence
South 67 degrees 27 minutes West 270.61 feet
along the Southerly line of said plat to the
easterly right-of-way line of Trunk Highway No.
75; thence Southeasterly along said right-of-
way line to the south line of said SE $\frac{1}{4}$; thence
Northeasterly to the Northeast corner of said
SE $\frac{1}{4}$; thence West along the North line of said
SE $\frac{1}{4}$ to the point of beginning.

For the purposes of this description, the
North line of said plat is considered due east-West.

and by amending said description to read as follows:

TRACT B

That part of the Southeast-Quarter (SE $\frac{1}{4}$) of
Section Thirteen (13), Township One Hundred
Sixty-one (161) North, Range Forty-nine (49)
West, Fifth Principal Meridian, Kittson County,
Minnesota, described as follows:

Beginning at the Northeast corner of the
plat of OSCAR NELSON'S FIRST ADDITION TO
HALLOCK, Minnesota, according to the recorded
plat thereof; thence South 790.00 feet along
the East line of said plat; thence West 580.00
feet along the southerly line of said plat; thence
South 246.91 feet along the easterly line of said
plat; thence South 67 degrees 27 minutes West
270.61 feet along the Southerly line of said
plat to the easterly right-of-way line of Trunk
Highway No. 75; thence southeasterly along said
right-of-way line 1112.88 feet; thence North
36 degrees 49 minutes 42 seconds East 2708.35
feet to the intersection with the northerly
line of said Southeast Quarter; thence West
along the north line of said SE $\frac{1}{4}$ 1221.79 feet
to the point of beginning, containing 39.90 acres
more or less.
