ORDINANCE NO. 175

July 11, 1978:

An Ordinance, Extending the boundary lines of said City of Le Center, Minnesota, so as to include in said City, the lands below and in this Ordinance described, and making said land a part of said City.

The City Council of Le Center, Minnesota does ordain as follows:

Section 1-That the following piece of land, all that part of the Northwest Quarter (NW $\frac{1}{4}$) of the Northwest Quarter (NW $\frac{1}{4}$) of Section No. 28, Township No. 111 North, Range No. 24 west, Le Sueur County, Minnesota, described as follows: Assuming that the west line of the Northwest Quarter (NW $\frac{1}{4}$) of said Section No. 28 in north & south-Beginning at a point on the west line of said Northwest Quarter (NW $\frac{1}{4}$), said point being 165.00 feet north of the Southwest corner of said Northwest Quarter (NW $\frac{1}{4}$) of the Northwest Quarter (NW $\frac{1}{4}$), thence east 173.00 feet thence north parallel with the west line of said Northwest Quarter (NW $\frac{1}{4}$) 881.82 feet, thence north 89 degrees, 46 minutes west 173.00 feet to the west line of said Northwest Quarter (NW $\frac{1}{4}$), thence south on said west line 882.52 feet to place of beginning. Containing 3.50 acres.

Section 2-The Boundary Lines of said City of Le Center, Minnesota, are hereby enlarged to cover said above land.

Section 3-This Ordinance shall take effect from and after its passage and publication.

Section 4-Passed by the City Council of Le Center, Minnesota, this 11th day of July, 1978.


