ORDINANCE NO. 402

THE COUNCIL OF THE CITY OF MORRIS DOES HEREBY ORDAIN:

SECTION I

That the following described property be, and hereby is, annexed to the corporate limits of the City of Morris:

That part of the Southeast Quarter (SE $\frac{1}{4}$) of Section 2, Township One Hundred Twenty-four (124) North, Range Forty-two (42) West described as follows: Commencing at a point 1543.5 feet south of the center of said Section 2, Township 124 North, Range 42 West on the Quarter line between the Southeast and Southwest Quarters of said Section 2, Township 124 North, Range 42 West; Thence Easterly along the South boundary of Elles Addition a distance of 180 feet which is the point of beginning of parcel to be described; thence due South a distance of 316.0 feet; thence southwesterly on a curve with a central angle of 55 degrees 00 minutes and a radius of 130 feet a distance of 124.79 feet; thence continuing southwesterly and at right angle to State Trunk Highway No. 9 a distance of 12 feet to the northeasterly right of way line of said Trunk Highway No. 9; thence southeasterly and along the northeasterly right of way line of Trunk Highway No. 9 a distance of 148.1 feet; thence northeasterly a distance of 200.8 feet to a point which is 463.25 feet due south of the south border of Elles Addition; thence due north a distance of 463.25 feet to the South border of said Elles Addition; thence West and along the south border of Elles Addition a distance of 200.0 feet to the point of beginning and there terminating, containing in all 2.50 acres more or less.


