ORDINANCE NO. 32

2nd Series

ORDINANCE DECLARING CERTAIN LAND TO BE
ANNEXED TO THE CITY OF NORTH MANKATO

The Common Council of the City of North Mankato, Minnesota,
does ordain as follows:

Section 1. The following tracts of land, the same being completely surrounded by land already within the municipal limits of the City of North Mankato, and being in the County of Nicollet, described as follows:

Beginning at the East quarter corner of Section 10, Township 108 North, Range 27 West; thence South along the East line of the Southeast quarter of said Section 10, 545.5 feet to the southerly right of way line of Minnesota Trunk Highway #14; thence North 28 degrees 42½ minutes West along the southerly right of way line to the North line of the Southeast quarter of said Section 10; thence East along the North line of said Southeast quarter to the point of beginning; also,

Beginning at the West quarter corner of Section 11, Township 108 North, Range 27 West; thence South along the West line of the Northwest quarter of the Southwest quarter of said Section 11, 545.5 feet to the southerly right of way line of said Trunk Highway #14, the point of beginning; thence South 28 degrees 42½ minutes East along the southerly right of way line of said Trunk Highway #14 for a distance of 414 feet; thence North 61 degrees 17½ minutes East, a distance of 150 feet to the northerly right of way line of said Trunk Highway #14; thence North 28 degrees 42½ minutes East, along the northerly right of way line of said Trunk Highway #14, for a distance of 694.7 feet, more or less to the West line of the Northwest quarter of the Southwest quarter of said Section 11; thence South along the West line of said Northwest quarter of the Southwest quarter to the point of beginning,

are hereby annexed and declared to be a part of the City of North Mankato and to be included in the corporate limits thereof.

Section 2. This ordinance shall take effect from and after its date of passage and publication.


