ORDINANCE NO. 160

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ROSEAU, MINNESOTA, TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND (UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA) ABUTTING UPON THE ROSEAU CITY LIMITS.

WHEREAS, a certain Petition dated March 22, 1978, requesting annexation of the territory hereinafter described was duly presented to the Council on the 10th day of April, 1978; and

WHEREAS, the quantity of land embraced within the area described in the Petition and bounded as described consists of less than 200 acres of unplatted land, no part of which is included within the limits of an incorporated city, or borough; and

WHEREAS, the Petition was signed by all of the owners of said real estate; and

WHEREAS, no objections to the annexation have been received from the Jadis Town Board, the Roseau County Board of Commissioners, the Minnesota Municipal Commission, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed and that the Jadis Town Board has executed a written consent to said Annexation; and

WHEREAS, the land described in the Petition abuts upon the city limits of the City of Roseau, Minnesota, at the west boundary thereof.

THE COUNCIL OF THE CITY OF ROSEAU, MINNESOTA, ORDAINS:

Section 1. The City Council hereby determines:

- (1) That the annexation will be in the best interests of the City and of the territory affected;
- (2) That the territory described herein abuts upon the City limits and is urban or suburban in character; and

Section 2. Territory Annexed.

The corporate limits of the City of Roseau are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

All that part of the West Three Hundred (300) feet of the Northeast Quarter of the Northwest Quarter (NE\(\frac{1}{2}\)NW\(\frac{1}{2}\)) of Section Twenty-three (23), Township One Hundred Sixty-two (162) North, Range Forty (40) West, lying and being Northerly of the Northerly right-of-way line of the Burlington Northern Railway

AND

The Northwest Quarter of the Northwest Quarter (NW\(\frac{1}{2}\)North, Of Section Twenty-three (23), Town-ship One Hundred Sixty-two (162) North, Range Forty (40) West, EXCEPTING therefrom the following described real estate owned by the City of Roseau, Minnesota:

Part of the NW\(\) NW\(\) of Sec. 23, T. 162 N.,
R. 40 W. described as follows: Beginning at
a point on the West line of said Sec. 23,
which point lies 751.15 feet South of the NW
corner of said Section; thence at right angles
East a distance of 150 feet; thence at right
angles South a distance of 100 feet; thence at
right angles West a distance of 150 feet to
the West line of said Sec. 23; thence North
a distance of 100 feet to the point of beginning,
containing 0.34 acre, more or less.

Section 3. Filing.

The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, Secretary of State of Minnesota, the Jadis Town Clerk, and the Roseau County Auditor.

Section 4. Effective Date.

This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
