Ordinance 47

AN ORDINANCE ANNEXING CERTAIN REAL ESTATE DESCRIBED HEREIN

WHEREAS, a petition for the annexation of certain land described hereafter, was signed and filed by the owners thereof Duane Prochaska, Carol Prochaska, Clarence E. Ruzicka, and Mildred I. Ruzicka, with the City Clerk of the City of Silver Lake, on or about the 24th day of March 1978; and

WHEREAS, the owners of the remaining part of the land to be annexed, namely, Dale Miska and Sharon Miska, joined in said Petition by filing a Petition for Annexation ratifying the Petition of the foregoing parties, said Petition being dated the 15th day of May, 1978; and

WHEREAS, the Petition for said annexation was filed and served upon the Minnesota Municipal Commission, Hale Township Board, and the McLeod County Board of Commissioners on or about the 24th day of March, 1978; and,

WHEREAS, none of the afore mentioned governmental bodies have submitted written objections to the annexation with the Commission; and,

WHEREAS, the Council of the City of Silver Lake has made the determination that the annexation will be to the best interest of the municipality and the territory affected;

NOW, THEREFORE, be it enacted that from this day forward the following described real estate be annexed to the City of Silver Lake and be incorporated as a part of said City:

Ruzicka's Addition, as of record and on file in the office of the County Recorder in and for the County of McLeod, State of Minnesota, described as follows:

All that part of the Southeast Quarter of the Southeast Quarter of Section 28, Township 117 North, Range 28 West, described as follows: Beginning at a point 660.0 feet north and 679.2 feet west of the southeast corner of said Section 28; thence South 0 degrees 00' East, a distance of 477.0 feet; thence North 89 degrees 32' West, a distance of 531.90 feet; thence North 0 degrees 00' East, a distance of 117.0 feet; thence North 60 degrees 39' East, a distance of 351.92 feet; thence North 0 degrees 00' East, a distance of 185.0 feet; thence South 89 degrees 32' East, a distance of 225.15 feet to the point of beginning. Containing 3.91 acres.

Said Ordinance passed by the City Council of the City of Silver Lake, this 19th day of June, 1978.
