## ORDINANCE NO. 688

An Ordinance Extending the Corporate Limits of the Gity of Willman, a Municipal Corporation of the State of Minnesota, to Include Certain Lands Not Exceeding 200 Acres.

WHEREAS, a petition has been filed with the governing body of the City of Willman, a municipal corporation in the State of Minnesota, by the sole owner having an interest therein, to have certain real property hereinafter described included within the limits of the City of Willman, Minnesota, and

where AS, it is proposed to sinex by virtue hereof to the said City of Willman, said property, all of which said property is in Kandiyohi County, State of Minnesota, and

where AS, pursuant to Minnesota law, said land may be annexed by ordinance.

WHEREAS, the said property to be annexed consists of approximately 10.6 acres, more or less, described as follows, to-wit:

Those parts of the SW4 of NE4 and the NW4 of of SE4, Section 14, Township 119, Range 35 described as follows:

Tract 1 — Commencing at a point 27572 feet south of the center of said section 14 and on the north and south quarter line of said section; thence running east and parallel with the east and west quarter line of said section a distance of 393.61 feet, thence running south and parallel with the north and south quarter line of said section a distance of 774% feet; thence running west and parallel with the east and west quarter line of said section a distance of 393.61 feet; thence running north following the north and south quarter line of said section a distance of 774% feet to the place of beginning.

tion a distance of 7/42% feet to the place of beginning.

Tract 2 Commencing at a point 2757% feet south of the center of said section 14 and on the north and south quarter section line; thence running north and along said north and south quarter section line a distance of 388.67 feet; thence running east and parallel to the east and west quarter section line of said section 14 a distance of 393.61 feet; thence running south and parallel to the north and south quarter section line of said section 14 a distance of 388.67 feet; thence running west and parallel to the east and west quarter section line of said section 14 a distance of 393.61 feet to the place of beginning.

NOW, THEREFORE, the City Council of the City of Willman hereby determines, ordains and declares as fol-

Section I. BEST INTEREST OF THE CITY OF WILLIMAR AND AREA TO BE ANNEXED. That the annexation will be to the best interest of the City of Willmar, Minnesota, and of the territory affected.

Section 2. ABUTS ON CITY LIMITS. That the property above described abuts on the City limits, and is so conditioned as property to be subject to City government.

Section 3. ANNEXATION. That the said property is hereby annexed to, and included within, the City of Willmar, Minnesota, as effectually as if it has originally been a part thereof.

Section 4. ZONING. The area above described shall be zoned R-2, One and Two Family Residential District except the South 438 feet of the North 728 feet of the tracts above described which shall be zoned R-3, Multiple Residential District.

Section 5. EFFECTIVE DATE: This ordinance shall the filed and shall take effect and be of full force and effect from and after filing a vertificate thereof with the Minnesota Municipal Commission, the County of Kandi-

yohi, Minnesota, and the Secretary of State of the State of Minnesota, and from and after its passage and publication.
