An Ordinance Extending the Corporate Limits of the Gity of Willmar, A Municipal Corporation of the State of Minnesota, To Include Certain Lands Not Exceeding 200 Acres.

WHEREAS, a petition has been filed with the govern-ing body of the City of Willman, a municipal corporation in the State of Minnesota, by all of the owners having an interest therein, to have certain real property hereinafter described included within the limits of the City of Willmar, said property all of which had property is in Kandi-

yohi County, Minnesota, and
WHEREAS, it is proposed to aimes by virtue hereof
to the said City of Willmar, said property all of which said
property is in Kandlyohi County, Minnesota, and
WHEREAS, pursuant to Minnesota law, said land may

be annexed by ordinance.

WHEREAS, the said proporty to be annexed consists of approximately 28.14 acres, more or less, described as follows, to wit:

That part of the Northwest Quarter of the Southwest Quarter lying northerly of the south line of the North Half of the North Half of the Northwest Quarter, Section 13, Township 119 North, Range 35 West, Kandiyohi County, Minnesota, lying northerly and easterly of a line described as follows: Beginning at a point in the west line of the Southwest Quarter of said section 256.68 feet of the Southwest Quarter of said section 256.68 feet southerly of the northwest corner of said Southwest Quarter; thence easterly and parallel with the north line of said Southwest Quarter 208 feet; thence southerly and parallel with the west line of said Southwest Quarter to the south line of the North Half of the North Half of the South Half of the Northwest Quarter of the Southwest Quarter of said Section 13, and said line there terminating.

All that part of the West Half of the Northwest Quarter, Section 13, Township 119, Range 35, Kandiyohi County, Minnesota, described as follows:

Section 1. BEST INTEREST OF THE CITY OF WILLMAR AND AREA TO BE ANNEXED. That the annexation will be to the best interest of the City of Willmar, Minnesota, and of the territory affected.

Section 2. ABUTS ON CITY LIMITS. That the property above described abuts on the City limits, and is so conditioned as property to be subject to City government.

Section 3. ANNEXATION. That the said property is hereby annexed to, and included within, the City of Willmar, Minnesota, as effectually as if it has originally been a part thereof.

Section 4. ZONING. The area above described shall be zoned R-2, One and Two Family Residential District.

Section 5. EFFECTIVE DATE. This ordinance shall filed and shall take effect and be of full force and effect from and after filing a certificate thereof with the Minnesota Municipal Commission, the County of Kandiyohi, Minnesota, and the Secretary of State of the State of Minnesota, and from and after its passage and publica-
