

ORDER ORGANIZING THE TOWNSHIP OF STEAMBOAT RIVER

STATE OF MINNESOTA) SS.  
County of Hubbard )

In the matter of the petition of Ted Bates and others for the Organization of the District of Steamboat River in Hubbard County, Minnesota.

The above entitled matter came on duly to be heard by the Board of County Commissioners of said County, at the Hubbard County Courthouse in the City of Park Rapids in said County, on Tuesday the 1st day of August, 1978, at 9:00 o'clock A.M., pursuant to notice duly given as provided by law and the order of said Board; and the said Board having heard all persons interested in said matter, both for and against, finds as follows:

First - That said petition was presented to said Board on the 20th day of June, 1978; was signed and acknowledged by a majority of the freeholders qualified to vote, residing in the Unorganized District above specified.

Second - That notice of said hearing on said petition was duly given by publication of the order of said Board for said hearing in the newspaper known as the Park Rapids Enterprise published and printed in said County, at least ten days prior to said day of hearing; and by the posting of copies of said order in three of the most public places in said district above specified for at least thirty days before said day of hearing; and by service of said order by mail upon each of the Clerks of adjacent Townships, at least ten days before said day of hearing.

Third - That the District proposed to be organized contains thirty-six square miles within its boundaries, contains at least twenty-five qualified voters therein and had an assessed valuation of \$386,125. as of January 1, 1978.

Fourth - That it is expedient and for the best interests of the residents of said District and the County of Hubbard that said District be organized as a Township.


NOW THEREFORE IT IS ORDERED, That said petition be, and the same hereby is granted, and that said Township be named STEAMBOAT RIVER TOWNSHIP, that the boundaries of said Township be the same as the boundaries of the District as the same exists as of this date, and that the funds remaining in the account of the District at the time of its organizational meeting be turned over to the Treasurer of the Township after it is properly organized.






Dear Mr Roemer:
