

Ordinance No. 78-1

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF LINDSTROM TO INCLUDE CERTAIN UNINCORPORATED TERRITORY BORDERED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, or borough; and

WHEREAS, this territory is less than forty acres and 60% or more of the perimeter of this territory is bordered by lands already included within the corporate limits of the city and is deemed to be urban in character;

The City Council of Lindstrom ordains:

Section 1. Territory annexed. The corporate limits of the City of Lindstrom, Minnesota, are hereby extended to include the platted and unplatted territory containing less than forty acres and 60% or more of the perimeter of which territory is bordered by territory already included within the city limits, described as follows:

A parcel of land in Section 34, Township 34, Range 20, Chisago County, Minnesota, described as follows:


Commencing at the intersection of the northwesterly line of First Avenue North, as shown on the plat thereof on file and of record in the Office of the County Recorder in and for said County, and the west line of said Section 34, thence southerly along said west line of Section 34 to its intersection with the north line of Newell Avenue; thence easterly along said north line of Newell Avenue projected to a point on the shoreline of the bay of South Center Lake lying within Government Lot 9 of said Section 34; thence continuing northerly and easterly along the shoreline of said bay to a point on said shoreline established by the intersection of said shoreline and a line perpendicular to the southwesterly line of Block 6 of said Andrews Beach plat and said line touching the most westerly point of Lot 6, Block 7, of said Andrews Beach plat; thence northeasterly along said perpendicular line to the southwesterly line of said Block 6; thence northwesterly along the present Lindstrom City Boundary which is the southwesterly line of said Block 6, projected to the northeasterly line of Andrews Avenue projected, and the northwesterly line of First Avenue North, all as shown on said plat of Andrews Beach to the point of beginning, containing twenty-seven (27) acres, more or less.

Section 2. Filing. The city clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, the Town Clerk of the affected township and the Minnesota Municipal Board.

Section 3. Effective Date of Annexation. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2.
