PRINTER'S AFFIDAVIT OF PUBLICATION

being duly sworn, on oath says he is and during all the times herein stated has been the publisher and printer of the newspaper known as The Littlefork Times and has full knowledge of the facts herein stated as follows: (1) Said newspaper is printed in English language in newspaper format and in column and sheet form equivalent in printed space to at least 900 square inches. (2) Said newspaper is a weekly and is distributed at least once each week. (3) Said newspaper has 50% of its news columns devoted to news of local interest to the community which it purports to serve and does not wholly duplicate any other publication and is not made up entirely of patents, plate matter and advertisements. (4) Said newspaper is circulated in and near the municipality which it purports to serve, has at least 500 copies regularly delivered to paying subscribers, has an average of at least 75% of its total circulation currently paid or no more than three months in arrears and has entry as second-class matter in its local post-office. (5) Said newspaper purports to serve the City of Littlefork in the County of Koochiching and it has its known office of issue in the City of Littlefork in said county, established and open during its regular business hours for the gathering of news, sale of advertisements and sale of subscriptions and maintained by The Publisher of said newspaper or persons in his employ and subject to his direction and control during all such regular business hours and devoted exclusively during such regular business hours to the business of the newspaper and business related thereto. (6) Said newspaper files a copy of each issue immediately with the State Historical Society. (7) Said newspaper is made available at single or subscription prices to any person, corporation, partnership or other unincorporated association requesting the newspaper and making the applicable payment. (8) Said newspaper has complied with all the foregoing conditions for at least one year preceding the day or dates of publication mentioned below. (9) Said newspaper has filed with the Secretary of State of Minnesota prior to January 1, 1966 and each January 1 thereafter an affidavit in the form prescribed by the Secretary of State and signed by the publisher of said newspaper and sworn to before a notary public stating that the newspaper is a legal newspaper.

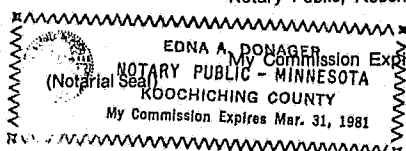

ORDINANCE NO. 64

AN ORDINANCE ANNEXING CERTAIN LAND TO THE CITY OF LITTLEFORK

WHEREAS, a petition has been duly filed pursuant to Minnesota Statute Sec. 414.033 to have the real estate hereinafter described annexed to the City of Littlefork, Minnesota; and

WHEREAS, said petition was signed by all of the owners of said real estate and duly filed with the City Council of Littlefork, Minnesota; the Koochiching County, Minnesota, Board of County Commissioners; and the Minnesota Municipal Board; and said real estate is unincorporated land abutting the City of Littlefork, is not included in any other municipality, does not abut or border on any other town, other municipality, or organized township, and is unplatted and it does not exceed 200 acres; and

WHEREAS, Koochiching County Board have waived and agreed to not object to such annexation; and

WHEREAS, the City is willing to immediately provide the area with police and fire protection and have the ability to eventually provide the area with water and sewer service; and

WHEREAS, the real estate hereinafter described contains approximately 46.15 acres, and

NOW, THEREFORE, The Council of the City of Littlefork, Minnesota, ordains:

1. That the annexation of the hereinafter described real estate is in the best interests of the City of Littlefork and of the territory affected, and the real estate hereinafter described is
