Ladies and Gentlemen:





ORDINANCE NO. 14 , 2ND SERIES

AN ORDINANCE ANNEXING CERTAIN LANDS
TO THE CITY OF THIEF RIVER FALLS

THE CITY COUNCIL OF THIEF RIVER FALLS, MINNESOTA, ORDAINS:

Section 1. WHEREAS, the sole owners of the following described premises situated in the County of Pennington and State of Minnesota, to-wit:

A parcel of land which is part of the Northwest Quarter of the Northwest Quarter (NW $\frac{1}{4}$ NW $\frac{1}{4}$) of Section Thirty-five (35), Township One Hundred Fifty-four (154) North, Range Forty-three (43) West, bounded as follows:

Beginning at the Southeast corner of Arthur's Third Addition to the City of Thief River Falls; thence due North along the East line of Cardinal Avenue to the North line of said Section Thirty-five (35); thence easterly along said North line a distance of 380.05 feet to an intersection with a line running North-South which is parallel to and 380 feet East of the East line of said Cardinal Avenue; thence due South along said parallel line to the North line of Robin Hood Drive extended; thence North 87° 01' 30" West a distance of 380.5 feet, more or less, to the point of beginning, containing 9.93 acres, more or less,

have petitioned to the City Council to have such land included within the City Limits of the City of Thief River Falls and have filed copies of said Petition with the Municipal Board of the State of Minnesota, with the Town Board of the Township of North of the County of Pennington and State of Minnesota and with the County Board of the County of Pennington, State of Minnesota, and

WHEREAS, the above described property abuts upon the boundaries of the City of Thief River Falls, and

WHEREAS, no objections to the proposed annexation have been submitted,

NOW, THEREFORE, it is hereby determined that the annexation of said premises will be to the best interests of the City of Thief River Falls and of the territory

affected and the above described premises are hereby declared annexed to the City of Thief River Falls.

Section 2. City Code Chapter 20, Listing of Uncoded Annexation Ordinances is hereby amended by addition of the foregoing ordinance to such listing.

Section 3. This ordinance shall be in force and effect from and after its passage, approval, publication and filing with the Municipal Board, the Town Clerk of North Township, the Pennington County Auditor, and the Secretary of State of the State of Minnesota.

Passed by the City Council of the City of Thief River Falls this 27th day of December, 1977.


