## ORDINANCE NO. 185

AN ORDINANCE AMENDING ORDINANCE NO. 169 OF THE CITY OF WACONIA ANNEXING CERTAIN LANDS INTO THE CORPORATE LIMITS OF THE CITY OF WACONIA

The City Council of the City of Waconia, State of Minnesota, ordains:

Section 1: That the legal description set forth in paragraph D, Section 2 thereof be amended in its entirety to read as follows:

D. All that part of the North Half of the Northeast Quarter (N<sup>1</sup>/<sub>2</sub> of NE<sup>1</sup>/<sub>4</sub>) of Section 23, Township 116 North, Range 25 West lying Southeasterly of County State Aid Highway 32, as same is now situated, and not already within the corporate limits of the City of Waconia.

Section 2: This Ordinance shall be in effect from and after its publication according to law.
