

AN ORDINANCE PROVIDING FOR ANNEXATION OF CÉRTAIN LAND ABUTTING THE CITY UPON PETITION OF ALL THE OWNERS OF SUCH LAND

THE CITY COUNCIL OF DELANO, MINNESOTA, ORDAINS:

SECTION 1. That pursuant to a petition by all of the owners of certain property comprising less than two hundred (200) acres, legally described as follows:

The East five (5) acres of Lot One (1) of the Northwest Quarter of Section 13, Township 118, Range 25, Wright County, Minnesota, also described as follows:

Commence at the Northwest corner of the Northwest Quarter of Section 13, Township 118, Range 25; thence South on the West section line a distance of 1320 feet to the 1/16 corner; thence East on the South line of the North half of the Northwest Quarter a distance of 1320 feet to the point of beginning; thence continue East on the South line of the North Half of the Northwest Quarter a distance of 440 feet; thence North parallel to the West section line a distance of 495 feet; thence West parallel with the South line of the North Half of the Northwest Quarter a distance of 440 feet; thence South a distance of 495 feet to the point of beginning,

the City Council has unanimously determined that said property is about to become urban in character;

SECTION 2. The tract hereinbefore described is, by this ordinnance, declared to be annexed to the City of Delano, Minnesota; and

SECTION 3. This ordinance shall take effect upon its passage and publication, and upon the filing of a copy of this ordinance with the Minnesota Municipal Board, Franklin Township, Wright County Auditor, and the Secretary of State for the State of Minnesota.
