ORDINANCE #332

ORDINANCE ANNEXING UNPLATTED LAND TO THE CITY OF SAUK RAPIDS UPON PETITION OF CYRLL REINERT

WHEREAS, the City of Sauk Rapids is desirous of annexing the following legally described property, to-wit:

That part of the East One-Half of the Southeast Quarter (E12 of SE4) of Section Fifteen (15), Township Thirty-six (36), North, Range Thirty-one (31) West, Benton County, Minnesota, described as follows: Commencing at the southeast corner of said Section; thence North on an assumed bearing along the east line of said Section a distance of 998.85 feet to the point of beginning of the land to be described; thence North 890 13' 45" West parallel with the south line of the North One-Half of the South One-Half of said Southeast Quarter 1280.71 feet, thence northwesterly 185.36 feet along a nontangential curve concave to the southeast having a radius of 692.91 feet and a central angle of 15° 19' 39", the chord of said curve bears North 20° 08' 50" East; thence North 62° 11' 20" West not tanget to said curve 66.00 feet; thence North 270 48' 40" East 651.02 feet; thence South 62° 11'20" East 632.00 feet; thence Southeasterly 161.97 feet along a tangential curve concave to the southwest having a radius of 149.23 feet and a central angle of 62° 11' 20"; thence south tangent to last described curve 300.00 feet; thence south 890 13' 45" East parallel with said south line of the North One-Half of the South One-Half of the Southeast Quarter 333.00 feet to the east line of said Section; thence South along said east line 66.01 feet to the point of beginning. Containing 12.90 acres more or less. Subject to the right-of-way of a Township Road over the most easterly 33.00 feet thereof and any easements of record.

WHEREAS, all of said property is unincorporated land, abutting on the City of Sauk Rapids, is not included in any other municipality, and does not border any other municipality; and

WHEREAS, said land is unplatted land, is not over 200 acres in area and is urban in character; and

WHEREAS, the annexation of said land to the City of Sauk Rapids,
Minnesota, will benefit the municipality and the territory herein described;
and

WHEREAS, a Waiver of Objections to the annexation was served on the Sauk Rapids Township Board, and said Township Board executed said Waiver indicating it has no objections to the Annexation herein; and

WHEREAS, said annexation petition was signed by 100% of the property owners of the land proposed to be annexed; and

WHEREAS, all requirements of Minnesota Statute 414.033 have been met; and

WHEREAS, the Sauk Rapids City Council hereby ordains as follows:

- 1. That the above described property shall be, and the same hereby is annexed to and included in the City of Sauk Rapids, Minnesota, as effectually as if originally made a part hereof.
- 2. That this ordinance shall take effect from and after its passage and publication as provided by law and upon filing of a copy of this ordinance with the Minnesota Municipal Commission, the Sauk Rapids Township Clerk, the Benton County Auditor, and the Minnesota Secretary of State, as required by Minnesota Statute 414.033, Subdivision 7.
