ORDINANCE NO. 25 , 2ND SERIES

AN ORDINANCE ANNEXING CERTAIN LANDS
TO THE CITY OF THIEF RIVER FALLS.

THE CITY COUNCIL OF THIEF RIVER FALLS, MINNESOTA, ORDAINS:

Section 1. WHEREAS, the sole owners of the following described premises situated in the County of Pennington and State of Minnesota, to-wit:

A tract of land which is part of the NE $\frac{1}{4}$, Section 32, Township 154 N., Range 43 West including Block 2 and Lots 1, 2 and 3 of Block 3 of Noper's Second Addition to Thief River Falls bounded as follows:

Beginning at the Southwest corner of Noper's Third Addition which point is the intersection of the West line of Noper Avenue and the South line of First Street; thence North along the West line of said Noper's Third Addition a distance of 706.259 feet to the Southerly line of Block 3 of said Noper's Second Addition; thence N 62° 20' 00" W a distance of 18,288 feet to the Southeastly corner of Lot 3 of Block 3 of said Noper's Second Addition; thence N 27° 40' 00" E a distance of 750 feet to the centerline of Minnesota Trunk Highway's 1 and 59; thence N 62° 20' 00" W along said centerline to an intersection with the North line of said Section 32; thence S 88° 38' 15" West along said North line to the Northwesterly corner of the NE $\frac{1}{4}$ of said Section 32; thence S 00° 08' 15" East along the West line of said NE $\frac{1}{4}$ a distance of 1928 feet more or less to an intersection with the South line of First Street extended; thence S 89° 28' 30" E along said South line to the point of beginning; containing 75.4 acres more or less,

have petitioned to the City Council to have such land included within the City Limits of the City of Thief River Falls and has filed copies of said Petition with the Municipal Board of the State of Minnesota, with the Town Board of the Township of North of the County of Pennington and State of Minnesota and with the County Board of the County of Pennington, State of Minnesota, and

WHEREAS, the above described property abuts upon the boundaries of the City of Thief River Falls, and

WHEREAS, no objections to the proposed annexation have been submitted,

NOW, THEREFORE, it is hereby determined that the annexation of said premises will be to the best interests of the City of Thief River Falls and of the territory affected and the above described premises are hereby declared annexed to the City of Thief River Falls.

Section 2. City Code Chapter 20, Listing of Uncoded Annexation Ordinances is hereby amended by addition of the foregoing ordinance to such listing.






