ORDINANCE NO. 67

AN ORDINANCE ANNEXING REAL ESTATE TO THE CITY OF TYLER

The City Council of the City of Tyler does ordain that:

WHEREAS, it is in the best interests of the City of Tyler and in the best interests of the territory described in the Petition for Annexation submitted to said City that the territory be annexed and,

WHEREAS, no objections to this annexation have been received by the City of Tyler,


THEREFORE, The City Council of the City of Tyler ordains that the following described real estate, including the abutting streets, highways, and rights of way are annexed and incorporated into the City of Tyler, Minnesota:

The West three hundred fifty and zero/hundredths feet (350.00'), of the east seven hundred seventy-two and fifty/hundredths feet (772.50'), of the Northeast Quarter (NE $\frac{1}{4}$ ), Section Nine (9), Township one Hundred Nine (109) North, Range Forty-four (44) West of the 5th P.M., Lincoln County, Minnesota between the present south right-of-way line of Minnesota Trunk Highway No. 14, and a line parallel to said south right-of-way, one thousand two hundred forty-four and fifty-seven/hundredths feet (1,244.57) south thereof, containing ten and zero/hundredths acres. (0.00Ac.)


All the above described property being in the County of Lincoln, State of Minnesota
