ORDINANCE NO 686

An Ordinance Amending Ordinance No. 683 by Correcting the Legal Description in Said Ordinance No. 683.

WHEREAS, the City Council of the City of Willmar did adopt Ordinance No. 683 of May 3, 1978; and

WHEREAS, said Ordinance was given its final publication on May 6, 1978; and

WHEREAS, Ordinance No. 683 is an ordinance extending the corporate limits of the City of Willmar; and

WHEREAS, the legal description contained in said Ordinance No. 683 is incorrect and the City Council of the City of Willmar is desirous of amending Ordinance No. 683 to provide the correct legal description of the premises to be annexed;

NOW, THEREFORE, the City of Willmar does hereby ordain as follows:

Section 1. Amendment of Legal Description. The legal description appearing in ordinance No. 683 adopted on May 3, 1978, and given its final publication on May 6, 1978, is amended by deleting said description in its entirety and replacing said description with the following description:

That part of the S $\frac{1}{2}$ of the SE $\frac{1}{4}$ of Section 22, Township 119, Range 35 described as follows: Beginning at the Southwest corner of Lot 1 of Block 5 of PORTLAND ACRES SECOND ADDITION, as of public record, Kandiyohi County, Minnesota; thence on an assumed bearing of EAST, along the South line of said PORTLAND ACRES SECOND ADDITION, 858.00 feet; thence on a bearing of S 75° 20' E, along said South line, 122.28 feet; thence on a bearing of EAST, along said South line, 121.00 feet to the East line of said PORTLAND ACRES SECOND ADDITION; thence on a bearing of N 0° 50' W, along last said line, 199.80 feet to the South line of PORTLAND ACRES, as of public record, Kandiyohi County, Minnesota; thence on a bearing of N 89° 59' E, along said South line, 839.80 feet to a line 405.00 feet West of the East line of said Section 22; thence on a bearing of S 0° 38' E, along last said line, 640.00 feet; thence on a bearing of S 89° 59' W, parallel with the South line of PORTLAND ACRES, 773.09 feet; thence on a bearing of N 0° 38' W, 125.00 feet; thence on a bearing of WEST, 66.00 feet; thence on a bearing of N 0° 38' W, 26.15 feet; thence on a bearing of WEST, 1099.91 feet to the Southerly extension of the West line of said PORTLAND ACRES SECOND ADDITION; thence on a bearing of N 0° 06' 30" W, along last said line, 320.00 feet to the point of beginning.

Section 2. Effective Date. This ordinance shall take effect and be of full force and effect from and after its adoption and second publication.
