ORDINANCE NO. 36, SECOND SERIES

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF JACKSON TO INCLUDE CERTAIN UNINCORPORATED, UNPLATTED LAND ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain petition dated the 20th day of May, 1976, requesting annexation of the territory hereinafter described was duly presented to the City Council on the 21st day of May, 1976; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 20.2 acres of unplatted land, no part of which is included within the limits of any incorporated city, village or borough, and

WHEREAS, the petition was signed by the owner of all of the land embraced within the area described in the petition; and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the City limits at the western boundary thereof;

THE CITY OF JACKSON ORDAINS:

Section 1. The City Council hereby determines (a) that the annexation will be to the best interests of the City and of the territory affected; (b) that the territory described herein abuts upon the city limits and is, or is about to become urban or suburban in character; and (c) that none of said territory is now included within the limits of any city, village or borough.

Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the unplatted land described as follows, and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof: (See Exhibit A attached hereto and made a part hereof.)

Section 3. Zoning District: The land hereby annexed to and included within the city is hereby designated as a Multiple Family Residence District, "R-3".

Section 4. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the Jackson County Auditor, the Clerk of Des Moines Township, Jackson County, Minnesota.

Section 5. Effective Date: This ordinance takes effect fourteen (14) days after its publication.

Introduced this 3rd day of August, 1976. Duly passed and adopted this 17th day of August, 1976.

The bearing of the west line said Sec. 23 is assumed due north.
