ORDINANCE NO. 93

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WEST CONCORD. MINNESOTA TO INCLUDE CERTAIN UNINCORPORATED TERRITORY BORDERED: BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, or borough, and

WHEREAS, 60% or more of the perimeter of this territory is bordered by lands already included within the corporate limits of the city and is deemed to be urban in character;

THE CITY COUNCIL OF WEST CONCORD, MINNESUTA ORDAINS:

Section 1. Territory Annexed. The corporate limits of the city of West Concord, Minnesota, are hereby extended to include the unplatted territory described as follows, 60% or more of the perimeter of which territory is bordered by territory already included within the city limits:

A tract of land in Dodge County, Minnesota, described as follows: Beginaming at the Northeast corner of the Southeast Quarter (SE& of Section Mineteen (19), Township One Hundred Eight (108) North of Range Seventeen (17) West, as a point of beginning, thence West 32 rods, thence South 10 rods thence East 32 rods, thence North 10 rods to the place of beginaming.

Section 2. Filing. The city clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the County in which the property is located, the Town Clerk of the affected township and the Minnesota Municipal Commission.

Section 3. Effective date of annexation. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2.
