Ladies and Gentlemen:





ORDINANCE NO. 75

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ARLINGTON TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain petition dated July 21st, 1978, requesting annexation of the territory hereinafter described was duly presented to the Council on the 7th day of August, 1978, and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 10 acres of unplatted land, no part of which is included within the limits of an incorporated city, and

WHEREAS, the petition was signed by all owners, and

WHEREAS, both the County Board of Sibley County and the Arlington Township Board of Sibley County have signed Waivers and Consents to the annexation of the premises described in the Petition, and

WHEREAS, the land described in the petition abuts upon the city limits at the east boundary thereof;

The Common Council of the City of Arlington, Minnesota, does ordain:

Section 1. The City Council hereby determines (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the city limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city.

Section 2. Territory annexed. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

That part of the S $\frac{1}{2}$ of SW $\frac{1}{4}$ of Section 10, Township 113 North, Range 27, Sibley County, Minnesota, described as follows: Commencing at the Southeast corner of Schumann & Kill Addition to the City of Arlington, Minnesota, said corner being on the South line of said S $\frac{1}{2}$ of SW $\frac{1}{4}$; thence Easterly along said South line of S $\frac{1}{2}$ of SW $\frac{1}{4}$ 610 feet to the actual point of beginning of the tract to be described; thence continuing Easterly along said South line of the S $\frac{1}{2}$ of SW $\frac{1}{4}$ 330 feet; thence Northerly parallel with the East line of said Schumann & Kill Addition to the North line of said S $\frac{1}{2}$ of SW $\frac{1}{4}$; thence Westerly along said North line of S $\frac{1}{2}$ of SW $\frac{1}{4}$ 330 feet to the East line of the Arlington Cemetery Association as now located; thence Southerly parallel with the East line of Schumann & Kill Addition to the point of beginning.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Board, the Township of Arlington, the Secretary of State, and the County Auditor.

Section 4. Effective Date of Annexation. This Ordinance takes effect thirty days after its passage and publication and the filing of certified copies as directed in Section 3.




