## ORDINANCE NO. 351

Breckenrelye

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF BRECKENRIDGE TO INCLUDE CERTAIN UNINCORPORATED LAND WHICH LAND IS ENTIRELY SURROUNDED BY LAND WITHIN THE MUNICIPAL LIMITS.

THE COUNCIL OF THE CITY OF BRECKENRIDGE, MINNESOTA, DOES ORDAIN:

WHEREAS, the below-described property is completely surrounded by land within the City limits of the City of Breckenridge,

AND WHEREAS, the City Council is of the opinion that such land is about to become urban in character,

AND WHEREAS, the Council is of the opinion and hereby finds that incorporating said below-described property is in the best interest of the City of Breckenridge and of the owners of said property.

NOW, THEREFORE, based upon the above findings, the Council of the City of Breckenridge, Minnesota, ordains:

Section 1. That the corporate limits of the City of Breckenridge, Minnesota, are hereby extended pursuant to Minnesota Statutes Section 414.033, Subd. 4, to include the land described as follows and the same is hereby annexed to be included within the City of Breckenridge, Minnesota, as effectually as if it had originally been a part thereof, which land is located in the County of Wilkin, State of Minnesota, and is described as follows, to-wit:

All that part of the Southwest Quarter (SW 1/4) of Section Thirty-four (34), Township One Hundred Thirty-three (133) North, Range Forty-seven (47) West, of the Fifth Principal Meridian, lying west of Trunk Highway No. 75, not now included within the city limits of the City of Breckenridge, Minnesota, and

All that part of the fractional Northeast Quarter of the Northwest Quarter (Fr NE 1/4 NW 1/4) of Section Four (4) in Township One Hundred Thirty-two (132) North, of Range Forty-seven (47) West, of the Fifth Principal Meridian lying west of Trunk Highway No. 75, not now included within the city limits of the City of Breckenridge, Minnesota, and

All that part of the Southeast Quarter of the Northwest Quarter (SE 1/4 NW 1/4) of Section Four (4) in Township One Hundred Thirty-two (132) North, of Range Forty-seven (47) West, of the Fifth Principal Meridian lying west of Trunk Highway No. 75, not now included within the city limits of the City of Breckenridge, Minnesota.

Section 2. That the City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission; the Secretary of State of Minnesota; the County Auditor of Wilkin County, Minnesota; and the Clerks of the Townships of Breckenridge and Connelly, Minnesota.

Section 3. This ordinance shall take effect upon its passage and publication at the time of filing of the certified copies as directed in Section 2 hereof.
