ORDINANCE 78-05

AN ORDINANCE ANNEXING CERTAIN LANDS LOCATED IN KALMAR TOWNSHIP TO  
CITY OF BYRON

The City Council of Byron, Minnesota, do ordain:

That the land located in Kalmar Township, Olmsted County,  
Minnesota described as follows to wit:

All that part of the followings described tract:

That part of the northeast quarter of the southwest quarter  
(NE $\frac{1}{4}$  SW $\frac{1}{4}$ ) of Section 32, Township 107 North, range 15 West,  
described by metes and bounds as follows: Beginning at a point  
on the east line of said quarter section which is 418.9 feet  
south of the northeast corner thereof; thence west at right  
angles a distance of 503 feet; thence north at right angles a  
distance of 185.9 feet to a point on the south right of way  
line of Trunk Highway No. 14; thence west along said right of  
way a distance of 330.75 feet; thence south at a deflection  
angle of 93 degrees 46 minutes 00 seconds to the left a distance  
of 540.7 feet; thence east at right angles a distance of 833 feet  
to a point on the east line of said quarter section; thence north  
along said line a distance of 333 feet to the place of beginning;

which lies northerly of a line parallel with and distant 204 feet southerly  
of the following described line:

Beginning at a point on the west line of said section 32, distant  
147.02 feet south of the west quarter corner thereof; thence run  
easterly at an angle of 90 degrees 54 minutes 13 seconds with said  
west section line (when measured from south to east) for 1629.99  
feet; thence deflect to the right on a 0 degree 10 minutes 00 second  
curve (delta angle 1 degree 30 minutes 05 seconds) for 900.82  
feet and there terminating;

containing 0.51 acre, more or less;

together with all right of access, being the right of ingress to and  
egress from that part of the above described tract not acquired herein,  
to Trunk Highway No. 14.

Section 32, Township 107, range 15.

That said property is unincorporated, abuts upon the limits of the City  
of Byron, and is not included within any other municipality.
